

Fresh PIL filed in SC on Adani-Hindenburg row

NEW DELHI, FEB 16/-/ A fresh PIL was filed on Thursday in the Supreme Court seeking a probe by multiple Central government agencies under the supervision of a panel or a supervision of a panel or a former apex court judge against the Adani Group of companies following allegations of fraud and share price manipulation made by the US-based Hindenburg Research. A bench headed by Chief Justice D Y Chandrachud is already

Chandrachud is already seized of as many as three PILs alleging exploitation of innocent investors and "artificial crashing" of the Adani Group's stock value, and they are listed for hearing on Friday. On Monday, the Centre had agreed to the apex court's proposal to set up a panel of experts to look into strengthening the regulatory mechanisms for the stock mechanisms for the stock market following the recent marketionowing the recent Adani group shares meltdown triggered by HindenburgResearch'sfraud allegations. Stock market regulator Securities and Exchange Board of India (SBBI), in its note filed in the apex court, had indicated it is not in favour of banning

short-selling or sale of borrowed shares, and said it is investigating allegations made by a tiny short-seller well as its share price

movements.
The fourth PIL has been filed by Mukesh Kumar, who claims to be a social worker, through lawyers Roopesh Singh Bhadauria and Mareesh Pravir Sahay.
Lawyer Bhadauria also heads Lawyer Bhadauria also heads the legal cell of the Indian Youth Congress (IYC). "Direct appropriate audit (transactional and forensic (transactional and forensic audits), inquiry and investigation by appropriate agencies such as Serious Frauds Investigation Office (SFIO); Registrar of Companies (RoC); Securities and Exchange Board of India (SEBI); ED (Directorate of Enforcement) on money-laundering aspect; I-T (Income-Tax) Department on aspects of offshore (Income-Tax Department on aspects of offshore transactions and tax-havens involved and DRI(Department of Revenue Intelligence), "the plea said. It said various aspects of corporate mis-governance have come to light including the roles of concerned agencies and authorities such as DRI and SEBI. StateBankofIndia's(SBI) State Bank of India's (SBI) exposure to Adani Group companies is close to Rs 27.000 crores while LIC has invested more than US \$4 billion in the conglomerat. It is well-known that crores of medium and small scale investors have put in their life-savings in SBI and In LIC policies and such serious exposure cannot be brushed away with simple statements," it said. There has been some delay in launching the 24-hour channel as we made all preparations and set up studios with ultramodern equipment, created digital walls and linked them with DTH to expand coverage," he said.

There is no dearth of talent in the state but the achievements of local residents are not adequately highlighted unless they are published in newspapers and broadcast on Tt, the minister said, adding that this channel will de decidated to famous tourist destinations, religious places, the youth, women, folk music, and dances writers.

Tharoor said the convention Tharoor said the convention comes at an "inflection point" in the party's history as it is being held after the presidential polls and the Bharat Jodo Yatra, andahead of the 2024 elections. The Lok Sabha MP from Thiruwananthapuram said the plenary could not have come at a more opportune time and gives the party members an opportunity to focus on what "we have gained and what faces the party in terms of challenges for the future". Asked if it was essential for the party to have polls for the GWC at the party's plenary session and ifhehadraised this issue with the party leadership, Tharoor said: "I had made the point that elections are healthy for the party and participated in one election myself and now that I have lost, I don't think it is my business to tell the party leadership what to do. Let them take the steps that they judge are appropriate." Hestressed themajority view in the All India Congress Committee (AICC) is the view that will prevail. "Iamfairly confident that if a majority of the delegates want an election they will hold one and if the majority feels that they would rather not rock the boat at this time and just move ahead, then that too will be a possible option," the former Union minister said.
