Declaration of results on the voting on resolution(s) set out in the Notice of the 36th Annual General Meeting of the Company held through Video Conferencing ("VC") and Other Audio-Visual Means ("OAVM") on Monday, 30th September 2024.

Further, pursuant to the provisions of section 108 and 109 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 (as amended) and Regulations 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with MCA circulars, the Company had provided the members the facility to exercise their voting rights electronically through remote e-voting process and also provided e-voting platform to the shareholders, who were present at the 36th Annual General Meeting through video conferencing/ other audio visual means and who had not cast their vote through remote e-voting on the resolution as set out in the notice.

The Company had appointed Mr. Deepak Kumar Dhir, a Practicing Company Secretary (Membership No. 45930), Partner of M/s. Deepak Dhir & Associates, Company Secretaries as the scrutinizer for the purpose of scrutinizing the process of e-voting and e-voting process during the AGM.

The Scrutinizer has carried out the scrutiny of all the electronic votes received up to the close of remote e-voting period on 30th September, 2024 and voting received till the conclusion of the meeting and submitted his Report on 01st October, 2024.
